



BYLAWS

University of Justice and Wisdom (Nonprofit – Ohio)

Article 1: Name and Purpose

1.1 Name

The organization is the University of Justice and Wisdom, a nonprofit educational institution incorporated in the State of Ohio.

1.2 Purpose

The organization operates exclusively for educational and charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, including:

- * Delivering academic programs and online education
- * Supporting research and scholarly publishing
- * Providing community education and leadership development
- * Any other charitable or educational activities consistent with 501(c)(3)

Article 2: Board of Directors

2.1 Authority

The Board of Directors governs the organization and oversees policies, programs, finances, and legal compliance.

2.2 Number of Directors

The Board shall consist of at least one director, with the ability to expand as needed.

2.3 Appointment

Directors are appointed by the Founder/Executive Director.

2.4 Term of Service

Directors serve three-year renewable terms.

2.5 Powers and Responsibilities

The Board is responsible for:

- * Approving policies and institutional direction
- * Approving the annual budget
- * Overseeing compliance with state and federal regulations

- * Appointing or removing officers
- * Ensuring the organization fulfills its charitable mission

2.6 Meetings

The Board shall meet at least once annually, with additional meetings held in person or electronically as needed.

2.7 Quorum

A majority of directors constitutes a quorum for conducting official business.

Article 3: Officers

3.1 Positions

The officers of the organization include:

- * President / Executive Director
- * Secretary
- * Treasurer

One individual may hold multiple positions when necessary.

3.2 Appointment

Officers are appointed by the Board of Directors.

3.3 Duties

- * President / Executive Director: Provides overall leadership, manages operations, and represents the organization.
- * Secretary: Maintains official records, meeting minutes, and organizational documents.
- * Treasurer: Oversees financial management, reporting, and budgeting.

Article 4: Conflict of Interest

4.1 Policy

All directors and officers must disclose any actual or potential conflicts of interest.

4.2 Procedure

No individual may participate in decisions that result in personal financial benefit.

Article 5: Prohibited Activities

5.1 Restrictions

The organization shall not:

- * Engage in activities inconsistent with 501(c)(3) status
- * Participate in political campaigns or support candidates
- * Distribute earnings or assets to any individual

Article 6: Financial Records

6.1 Fiscal Year

The fiscal year ends on December 31.

6.2 Records

Accurate financial records shall be maintained and reviewed as needed.

Article 7: Amendments

7.1 Amendments

These bylaws may be amended by a majority vote of the Board of Directors.

Article 8: Dissolution

8.1 Distribution of Assets

Upon dissolution, all assets shall be distributed to another educational or charitable organization that qualifies under Section 501(c)(3). No assets may be distributed to any individual.
