



Terms of Use — University of Justice and Wisdom

Effective Date: April 27, 2026

1. Acceptance of Terms

By accessing, browsing, or using the website located at www.uojaw.education (the “Website”), you acknowledge that you have read, understood, and agree to be bound by these Terms of Use. If you do not agree to these terms, you must discontinue use of the Website immediately.

2. Use of Website

The Website is provided by the University of Justice and Wisdom (“UJW”) for informational and educational purposes. You agree that you will use the Website only for lawful purposes and in a manner consistent with these Terms of Use. You must not:
